
Reference Departmental Selection Committee Advt. No. 01, dated 06-03-2013, which was published in various newspapers for recruitment of 471 posts of Forest Guard for Forest Department, Haryana..

Keeping in view the large number of applications received and as per conditions of advertisement, the Departmental Selection Committee has decided to shortlist the candidates in the respective category for interview on the basis of marks obtained in the essential academic qualification advertised: **Matriculation or equivalent examination from a recognised State Education Board/University.** The minimum cut off percentage of marks in qualifying examination for various reserved categories who qualify for interview call are given below:-

1. The percentage of marks obtained in qualifying examination as provided in the application form by the applicant has been considered for short listing the candidate. CGPA score provided by the candidates has been converted into percentage of marks by multiplying by a factor provided in the mark sheet issued by the Examination Board. The maximum marks for interview will be 50. Final merit list will be prepared by adding marks obtained in qualifying examination (in percentage) and interview.
2. All the shortlisted candidates with the above mentioned percentage or higher percentage of marks in qualifying examination will be called for **Physical Efficiency Test (PET- physical measurement and walking test as per the advertisement)** and interview at designated place and date mentioned in the call letter.
3. **CALL LETTER** for PET and interview can be downloaded from the website [www.haryanaforest.gov.in](http://www.haryanaforest.gov.in) after **09-12-2013**. **For downloading the call letter candidates having percentage of marks equal or above cutoff marks for various categories mentioned above can log on the website with following mandatory keys (personal details) as provided in original application form: Post applied for, Category, Date of Birth, Name and Father's Name.** Call letter can be downloaded from any personal computer (PC) with internet connection or cyber cafe or in the office of Divisional Forest Officer in the District. Addresses of Divisional Forest Officers are available on the website. **No call letter will be sent by post to individual shortlisted candidate.** Candidates with percentage of marks equal or above the cut off marks for various categories mentioned above, who could not download the CALL LETTER, can send written request on prescribed form which can be downloaded from the website, **before 20.12.2013**. If they are found eligible then the list of eligible candidates will be issued and list will be posted on website and they will be able to download CALL LETTER after **01.01.2014** and those candidates will be called for PET at place and date as mentioned in the CALL LETTER. **No call letter will be sent by post to these candidates also.** However, those candidates who do not possess the minimum cut off percentage of marks for shortlisting under their respective categories mentioned above are advised not to contact the Departmental Selection Committee Office in this regard.
4. Candidates should bring photo Identity Card (ID) such as a) Passport, b) Driving licence, c) PAN Card, d) Voter ID Card, e) Adhar Card or any other Identity Card issued by School/College/University or Government Department
5. **PET will be held 17-12-2013 onwards or as mentioned in the Call Letter downloaded by shortlisted candidates.**
6. Those candidates who qualify the PET (physical measurement and walking test as mentioned in the advertisement) will be issued a certificate by the concerned DFO signed both by DFO and the candidate which the candidate will produce in original at the time of interview at date and place mentioned in the call letter. Candidate has to sign the PET register maintained at the PET site after PET and then obtain the PET certificate. **Candidates disqualified in PET need not report for interview.**
7. The eligible candidates are advised to read the above mentioned notice carefully and **must download the CALL LETTER before 16.12.2013** and attend the PET and interview on the dates as per details in the call letter.
8. Shortlisted candidates should bring all certificates and documents in original at the time of interview.
9. Shortlisted candidates will have to make their own arrangement for travel and stay at the place of physical efficiency test (PET) and interview and no travelling and daily allowance will be given by the Departmental Selection Committee.
10. The date and place of PET and interview may change without any advance notice due to unavoidable reasons.
