
TENDER NOTICE

Sealed tenders are invited from bonafide eligible Tenderers for the supply of **10 tonnes (10,000 kg) Vermiculite** under the following terms and conditions.

1. The rates quoted in the Tender Application Form, enclosed with the notice along with the terms and conditions of the tender, duly signed by the tenderer enclosed in a sealed envelope shall be deposited in the tender box kept in the office of DFO, CFP, Kurukshetra before **24 July** at 12.00 noon and will be opened at 12.30 pm on the same day by DFO, CFP or official authorized by him in the presence of tenderer or their representatives. Tender forms may be obtained from the office of DFO, CFP on the payment of Rs 500/- on or before 11.00 am on **24-07-2017**. If the form is downloaded, draft of Rs. 500/- from any nationalised bank favouring DFO, CFP, Kurukshetra will have to be deposited.
2. Specifications of the material to be supplied are as under:

Material:	Vermiculite (Exfoliated)
Grade:	Horticulture grade
Particle Size:	2 to 4 mm – 90 to 95%
	<2mm – less than 5%
	>4mm – 2 to 4 %
3. The bids should be accompanied by a sample of the item/material to be supplied. Tender not accompanied by the sample shall be summarily rejected.
4. Tenderer shall deposit EMD for the amount indicated in the Tender Application Form through Bank Draft or Deposit at Call from any of nationalised bank in favour of DFO, CFP, Kurukshetra payable at Kurukshetra.
5. Tender not accompanied by EMD shall be summarily rejected.
6. Cost of material, applicable taxes and transportation cost should be mentioned separately.
7. Material is to be delivered at nursery at Village Seonthe, Distt. Kurukshetra, 10 km from Pipli on Kurukshetra – Saharanpur state highway.
8. Tenderer shall complete the supply of stores/work within 15 days from the date of issue of order.
9. In case of failure on part of the tenderer to complete work/supply the stores within the stipulated period of time, the EMD so deposited shall be forfeited to the Government account and the work will be got done at his/her risk and cost.

10. The work completed/stores supplied shall be inspected by DFO, CFP Kurukshetra or his representative.
11. The payment shall be released after due verification by DFO, CFP, Kurukshetra or his representative.
12. In case of any dispute, the decision of the Conservator of Forests shall be final and binding to both the parties.
13. All disputes shall be subject to the jurisdiction of the appropriate court in Kurukshetra.
14. DFO, CFP reserves the right to cancel any or all the Tenders without assigning any reason thereof.
15. Tenderer shall submit a copy of PAN card and TIN number duly attested by Gazetted Officer along with the tender.
